He mentioned that SCV Water hosted an employee family picnic at the Rio Vista Treatment Plant location this past Saturday, which included activities for the kids, food, and tours of the treatment plant. He gave a brief update on the recent PFAS case, stating that there has been another settlement proposal reached in the multi district AFFF litigation. He said, this time BASF will settle for \$312,500,000 bringing the total settlement across four parties to up to \$14,747,500. He advised that SCV Water is working on its first claims submittals for the DuPont and 3M portions of the settlement, reporting that payments will depend on the total quantity of claims and will be paid out over several years.
