ABOUT WELL 205

Constructed in 2000

Removed from service in 2012 due to contaminants:

- Volatile Organic Compounds (VOCs)
- Perchlorates

*** SCV Water did not place these contaminants in our water supply, but we are working hard to restore this drinking water source for our customers.






WHAT IS THE GOAL OF THIS PROJECT?

To provide our customers with clean, safe and reliable water by removing perchlorates and volatile organic compounds (VOCs) from our drinking water.




ABOUT THE WATER TREATMENT PROJECT AT WELL 205

- ~\$20 million investment in SCV Water's long-term water reliability
- Located on Valencia Parkway, adjacent to the City of Santa Clarita's McBean Regional Transit Center
- Restores water to nearly 5,000 households
- Removes VOCs and perchlorates

WHAT DOES THE PROJECT INCLUDE?


- 2 Treatment systems, including up to 3 pairs of VOC vessels and 2 pairs of perchlorate vessels
- 1 Washwater tank
- 2 Washwater pumps

- 1 Chemical building
- 1 New driveway
- Perimeter block wall lined with trees surrounding the facility








WHAT CAN WE EXPECT DURING CONSTRUCTION?

- All supplies and equipment will be entirely contained within the perimeter of the well property.
- Vehicles will enter/exit from the driveway on Valencia Blvd and McBean Pkwy.
 No vehicles or equipment will go through the adjacent neighborhoods.
- There are no planned water shutdowns during this project.



WHAT CAN WE EXPECT AFTER CONSTRUCTION IS COMPLETE?



Most equipment will not be too visible.



 The site will have minimal operational noise.



Trees will be planted around the facility.



WHAT IS SCV WATER DOING TO ENSURE WATER QUALITY AND DRINKING WATER SUPPLY?

- We are committed to immediately removing wells from service if we find out they fail to meet state or federal water quality levels.
- SCV Water proactively samples water in our wells quarterly to ensure they are in-line with state and federal standards.
- We invest in technology and equipment to ensure our water is effectively treated before reaching our customers.




